This template can be used for multiple purposes:

- It enables schools to effectively plan their use of the Primary PE and sport premium
- It helps schools to meet the requirements (as set out in guidance) to publish information on their Primary PE and sport premium
- It will be an effective document to support Ofsted inspections enabling schools to evidence progress in Physical Education (PE) and evidence swimming attainment, which forms part of the PE National Curriculum. We would recommend schools consider the Intent, Implementation and Impact of any spend, as examined within the Education Inspection Framework.

It is important that your grant is used effectively and based on school need.

Schools must use the funding to make **additional and sustainable improvements** to the quality of the PE, School Sport and Physical Activity (PESSPA) they offer. This means that you should use the Primary PE and sport premium to:

- Build capacity and capability within the school to ensure that improvements made now will benefit pupils joining the school in future years
- Develop or add to the PESSPA activities that your school already offers.

The Primary PE and sport premium should not be used to fund capital spend projects; the school's core budget should fund these. Further detail on capital expenditure can be found in the updated [Primary PE and sport premium guidance](#).

The Primary PE and sport premium guidance, outlines 5 key priorities that funding should be used towards. It is not



necessary that spending has to meet all the key priorities, you should select the priorities that you aim to use any funding towards.

Although completing this template is not a requirement for schools, schools are required to publish details of how they spend this funding. Schools must also outline what the impact this funding has had on pupils' PE and sport participation and attainment and how any spending will be sustainable in the future. **All funding must be spent by 31st July 2024.**

The Department for Education has worked closely with the Association for Physical Education (afPE) and the Youth Sport Trust (YST) to develop this template and encourages schools to use it. This template is an effective way of meeting the reporting requirements of the Primary PE and sport premium.

Once again, the pupils are competing regularly against other schools in inter-school competitions. 	<ul style="list-style-type: none"> - Although an expensive outlay, having the swimming pool this year for three entire year groups (nine classes) has proved a huge success and is something that we will be rebooking for the next academic year. - It has been a really positive experience for everyone involved watching beginners move forward and more advanced children being recognised and celebrating their successes. - Continue to offer a broad and varied range of sporting clubs in the future. - Aim to establish further links and introduce other events involving different sports into the school calendar. - Look into ways in which we can deliver lessons which further extend the more able pupils. - Continue to look for opportunities to take pupils to sporting events off-site in order to provide enriching and memorable experiences. - Working with other P.E. coordinators, the aim in the future, partly through use of sport premium funding, is to grow the calendar further.

Swimming Data

Meeting National Curriculum requirements for swimming and water safety.

Priority should always be given to ensuring that pupils can perform safe self-rescue even if they do not fully meet the first two requirements of the National Curriculum programme of study

What percentage of your current Year 6 cohort can swim competently, confidently and proficiently over a distance of at least 25 metres?	53%	53% - After Covid, we were not able to secure a swimming slot at a local swimming pool as we had in previous years. This was our first year of successfully using a swimming pool onsite. We were able to get Year 4, Year 5 and most importantly Year 6 in the pool swimming every day. When we evaluated the impact of the sessions, we found that having a concentrated block had some huge benefits and over the course of the three weeks an increasing number of children were able to swim up to the benchmark distance of 25 metres and beyond.
What percentage of your current Year 6 cohort can use a range of strokes effectively [for example, front crawl, backstroke, and breaststroke]?	35%	

<p>What percentage of your current Year 6 cohort are able to perform safe self-rescue in different water-based situations?</p>	<p>88%</p>	<p>88% - The fact that the majority of our Year 6 pupils have received tuition and learned how to keep themselves safe when in different water-based situations is extremely pleasing. The data supports the approach that we adopted to swimming this year and the investment we made with regard to swimming.</p>
